

COOKIE POLICY

We inform you that you are in a web portal of Monopole Ltd where we use cookies in order to: (I) facilitate the use, (ii) facilitate navigation, (iii) improve the experience, (iv) comply with legal and contractual obligations, (v) profile and establish habits of the Owner, (vi) improve the quality of the page, according to the habits and navigation styles of users.

The data holder authorizes Monopole Ltd the use of its cookies in accordance with the Cookie Policy. Also, the holder authorizes the treatment of his information that had been collected at any time and anonymously, but that, by virtue of this authorization, can be identified and associated with your profile.

Definition of cookies: Cookies are small data files that are generated in the computer, Smartphone, iots (in English Internet of things) is a network of physical objects - vehicles, machines, appliances and more - that uses sensors to connect and exchange data over the Internet), tablet or any other electronic device of the user when accessing a website and that allow the holder of that page to store or retrieve certain information about the navigation that takes place from that computer.

Types of cookies

Below, we offer information about the type of cookies and their purpose:

Cookies according to the entity that manages them: According to who is the entity that manages the equipment or domain from which the cookies are sent and treats the data that is obtained, we can distinguish:

Own Cookies: Are those that are sent to the user's terminal equipment from a web portal own Monopole Ltd

Third party cookies: Are those that are sent to the user's terminal equipment from a computer or domain that is not managed by Monopole Ltd or the third party that Monopole Ltd has designated, but by another entity that treats the data obtained through cookies. Since these third parties are the ones who proceed to its implementation, the blocking and unblocking of them is governed by their specific conditions and mechanisms.

Types of cookies according to the length of time they remain activated in the terminal equipment

Session Cookies: These are a type of cookie designed to obtain and store data while the user accesses a web page. These cookies are stored in your terminal until the end of the user's browsing session.

Persistent cookies: They are a type of cookies in which the data is still stored in the terminal and can be accessed and treated during a period defined by the person responsible for the cookie, which can go from a few minutes to several years.

Types of cookies according to their purpose

Technical Cookies: These allow the user to navigate through the website or platform and use the different options or services that exist therein, such as controlling traffic and data communication, identifying the session, accessing parts of restricted access, using security elements during navigation or storing content for the dissemination of video or sound or sharing content through social networks such as Instagram, Twitter, Facebook, Google + or Youtube. These are session and persistent cookies.

Personalization cookies: These are cookies that allow the user to access the service with some predefined characteristics according to a series of criteria in the user's terminal, such as the type of browser through which the user accesses the service, the regional configuration from which the user accesses the service, etc.

Analytical Cookies: These allow us to quantify the number of users and thus carry out the measurement and statistical analysis of the use made by users of our website. For this purpose, their navigation on our website is analysed in order to improve it.

Advertising Cookies: Are those that allow the management, in the most efficient way possible, of the advertising spaces that could be included in our website.

Behavioral advertising cookies: These cookies store information on user behavior obtained through continuous observation. Thanks to them, we can know the habits of navigation in the Internet of the holder and show you advertising related to your navigation profile.

Cookies Management: You can allow, block or delete the cookies installed on your computer by configuring the options of your Internet browser. If you do not allow the installation of cookies in your browser you may not be able to access some of the services and your experience on our website may be less satisfactory.

Cookies management: You can allow, block or delete cookies installed on your computer by configuring your Internet browser options. If you do not allow cookies to be installed on your browser, you may not be able to access some of the services and your experience on our website may be less satisfactory.

Monopole Ltd can modify this policy of cookies according to regulatory requirements, legislation or in order to adapt this policy to the instructions given by the Office of the Information and Data Protection Commissioner of Malta. When navigating and continuing in our Web you indicate to us that you are making an unequivocal conduct in the acceptance of the use of the cookies before enunciated, and in the conditions contained in the present Policy of Cookies.
